Day One: Depart from your selected joining point and travel to Grange-over-Sands for your four nights stay at the Cumbria Grand Hotel. Comfort stops will be made en-route.

Day Two: Leaving the hotel the coach will travel to the small town of Ambleside, the market town of Keswick, which is situated between Skiddaw and Derwentwater, and Grasmere, known for William Wordsworth connections. You may like to purchase some of the legendary Grasmere Gingerbread! Continue along the shores of Ullswater, the second largest lake in the area and over the stunning Kirkstone Pass before returning to the hotel.

Day Three: A half day excursion to Windermere, a bustling town on the shores of Lake Windermere. Enjoy a stroll around the lovely town, perhaps visit The World of Beatrix Potter, take in the scenery by the lake or join one of the many delightful lake cruises. The remainder of the day is free in Grange-over-Sands. You may wish to take a walk in to the town or enjoy a stroll by the water.

Day Four: Spend the morning in the picturesque market town of Kirkby Lonsdale on the edge of the Yorkshire Dales and the afternoon in the historic town of Kendal, famed for its mint cake. There are two castles, museums, historic buildings and many independent shops.

Day Five: After breakfast you leave Grange-over-Sands and travel home. Comfort stops will be made en-route.
