Entry is included to the stunning Giant's Causeway, see the famous basalt columns and learn of its mystery and tales in the visitor centre. Leaving the Giants Causeway you will travel to Portstewart, a small Victorian seaside resort which has retained its heritage. It has a spectacular beach, a harbour and promenade.

Day Three: Discover the historic walled city of Londonderry/Derry during an informative guided tour followed by free time at leisure.
